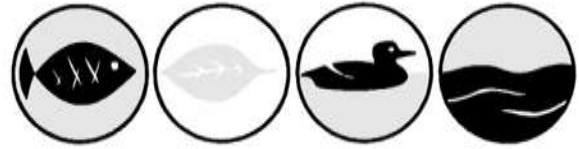

Our 61st Ice Fishing Derby

February 13 & 14

THE DERBY WILL BE HEADQUARTERED AT MUSKY TALES BOAT RAMP OFF OF ROUTE 173!

Looks like we'll have plenty of ice this year for our 61st derby. NICC has had many challenges with weather in the past 60 years. No matter what the weather NICC dedicated volunteer members worked to keep the derby going strong both days.

This year will be a little different because of COVID-19. There will be no gathering of people during the Derby. The fishermen will only come to shore to register and enter their fish. The two fish judges will be in a 12 x 12 tent with only one fisherman allowed in the tent at a time to enter their fish. There will be another 12 x 12 tent set up next to the fish judges and will be manned by one or two NICC members at a time who are there to answer any questions that the fisherman or public may have. Again, only one person allowed in the tent at a time.
